2. Administration fees

The annual administration fee is CHF 80.00. The administration fee is invoiced once a year on a monthly invoice.

3. Additional fees

3.1 Washing

MTM partners have the option of ordering washed EE. The fees shall be borne by the supplier and are:

For Migros EE type A/N CHF 0.17 / piece
For Migros EE type B/N, C/N, E/N, U CHF 0.28 / piece
For Migros EE type P1-01 CHF 1.00 / piece
For Migros EE type MaxiPac CHF 4.40 / piece

Only MTM partners with a valid washing contract shall be entitled to order washed EE. This contract can be signed with MTM.

3.2 Sorting

Automated sorting of pallets is charged for separately.

Normal sorting: CHF 2.30

Hygiene (visually bright): CHF 6.00 (very limited availability)

3.3 Transportation costs

Transportation costs for empty EE shall be borne by MTM partners themselves.

3.4 Emergency dispatch

For EE orders placed after 7.00 a.m. for the same or next day, charges will apply. For each emergency scheduling, CHF 50.00 will be invoiced to the MTM partner.

4. Terms of payment

Due fees are invoiced monthly and must be paid within 30 days.
